- The order form, changes and additional orders must be submitted at the latest 14 days prior to the exhibition. If not a surcharge of 10 % will become due (with exception of the exhibitors who are admitted at short notice). The contractor reserves the right to reject orders or order changes received late.

All cancellations will entail a cancellation fee:

- Cancellations 14 days prior to the exhibition will be charged at 25 % of the quoted price
 - 7 days prior to the exhibition will be charged at 50 % of the quoted price
 - Less than 7 days prior to the exhibition will be charged at 100 % of the quoted price.
